



## ONE YEAR PARTS AND LABOR LIMITED WARRANTY

This CMA Dishmachines Company warranty applies to all equipment that has been unaltered, properly installed and maintained in accordance with national/local codes and in accordance with the CMA installation manuals, when installed within the United States.

CMA products are warranted to the original purchaser to be free from defects in material and workmanship under normal use and service for a period of one (1) year from the date of original installation. This warranty does not apply to equipment that has been damaged, altered or abused accidentally or intentionally, modified by unqualified service personnel, shipped with missing or altered serial nameplates, or damaged as a result of fire, water, burglary, or "acts of God".

CMA agrees to repair or replace defective parts (with normal shipping charges) due to flaws in material or workmanship during the warranty period. Labor to repair or replace defective parts shall be warranted when performed by an authorized CMA service agency. This includes the use of factory-specified genuine replacement parts, purchased directly from a CMA-authorized parts distributor or service agency. Use of generic replacement parts may create a hazard and void warranty certification. CMA Dishmachines limits warranty travel time to (2) two hours, and mileage to (100) one-hundred miles.

Proper installation, initial start-up, or normal maintenance, such as lubrication, adjustment or calibration of controls, is the responsibility of the dealer, owner-user or installing contractor, and is not covered by this warranty.

**ITEMS NOT COVERED:** This warranty does not cover adjustments to timer cams or thermostats, cleaning wash arms or strainers, or replacement of wear items such as curtains, squeeze tubes, drain balls, door guides, gaskets or bearings. All plastic items are excluded from this warranty. Also not covered are conditions caused by the use of incorrect (non-commercial) grade detergents, water temperature or pressure, or hard water conditions.

The above states the entire warranty provided by CMA Dishmachines, and is in lieu of any and all other warranties expressed or implied.
